## SEYMOUR COMMUNITY SCHOOL BOARD REGULAR MEETING

The regular meeting of the Board of Directors of Seymour Community School District was held on April 18, 2022, in the Board room of the Seymour Community School.

President Justin Keller called the meeting to order at 6:30 p.m.

Members present were Justin Keller, Sarah Carter-Jones, Drew Power and Dan Furlin, Jr. Clint Housh was absent. Also present were Mr. Breon, Shannon Starr, Madison Keller, Ori Trimble, Missy Liggett, Mark Sprague, Sarah Jones, Brittany Banks, Samantha Carter, Jennifer Trimble, and Scott Valentine.

Dan Furlin, Jr. made a motion to approve the agenda. Sarah Carter-Jones seconded the motion. All voted in favor.

Dan Furlin, Jr. made a motion to approve the minutes from the previous meetings. Drew Power seconded the motion. All voted in favor.

Drew Power made a motion to approve the bills for payment. Sarah Carter-Jones seconded the motion. All voted in favor.

The District financial reports were reviewed.

President Justin Keller welcomed visitors. There were no public comments.

Board discussion items included pop can collection and student gate fees.

Mr. Breon had the following for Administration discussion: 1) The BGC recommends raising gate admission fees to \$5.00 for adults and students for Varsity/JV games and to \$3.00 for adults and students for JH games. Drew Power made a motion to approve the recommended gate admission fee increase. Sarah Carter-Jones seconded the motion. All voted in favor. 2) The District will host two home football games this fall. 3) The joint meeting with the Mormon Trail Board of Directors will be held on May 2, 2022, at 7:00 p.m.

Mrs. Starr reported on the following: 1) Day care information and a possible grant to pay for the DLR Group analysis fee, cribs, etc. 2) Playground work has begun. 3) The PTU Carnival will be held on May 6, 2022.

Mr. Breon reported the last meeting of the CSIAC Committee for the 2021-2022 school year was held on April 4, 2022. He noted that next year he may return

to sending out a letter of invitation to community members identified as people who may be interested in attending the meetings to encourage attendance.

Jennifer Trimble was present to request approval of her request to open enroll her daughter to Wayne CSD for the 2022-2023 school year. After discussion, Drew Power made a motion to approve the request. Sarah Carter-Jones seconded the motion. All voted in favor.

Drew Power made a motion to approve the Early Childhood Analysis and Improvements proposal from DLR Group in the amount of \$6,000.00 to provide professional architecture and engineering services for the analysis and upgrades for the early childhood center conversion. Dan Furlin, Jr. seconded the motion. All voted in favor.

Senior students Madison Keller and Ori Trimble were present to discuss plans for their senior trip to Chicago May 16-19, 2022, including a Cubs game, Navy Pier and Riverwalk . Drew Power made a motion to approve the senior trip to Chicago. Dan Furlin, Jr. seconded the motion. All voted in favor.

An eighth grade graduation ceremony was discussed. It was decided that parents need to work with Mrs. Houser on the matter.

Mr. Breon reported on his recommendations for sharing positions for the 2022-2023 school year. After discussion, Dan Furlin, Jr. made a motion to approve the sharing recommendations. Sarah Carter-Jones seconded the motion. All voted in favor. It was noted the additional state funding received through sharing would be the equivalent to 21 students.

Dan Furlin, Jr. made a motion to approve the school fees for the 2022-2023 school year as presented. Sarah Carter-Jones seconded the motion. All voted in favor.

Drew Power made a motion to provide transportation free or charge for students attending summer swim lessons. Dan Furlin, Jr. seconded the motion. All voted in favor.

There were no handbooks presented for approval.

Dan Furlin, Jr. made a motion to accept the resignation of Alicin Leager as Ag Teacher effective at the end of the 2021-2022 school year. Drew Power seconded the motion. All voted in favor.

Drew Power made a motion to accept the resignation of Rylie Graham as Music Teacher effective at the end of the 2021-2022 school year. Sarah Carter-Jones seconded the motion. All voted in favor.

Dan Furlin, Jr. made a motion to accept the resignation of Tamara Carel as Teacher effective at the end of the 2021-2022 school year. Sarah Carter-Jones seconded the motion. All voted in favor.

Dan Furlin, Jr. made a motion to approve the hire of Rachel Beary as Ag Teacher for the 2022-2023 school year. Sarah Carter-Jones seconded the motion. All voted in favor.

Drew Power made a motion to approve the hire of Brennan Banks-Christianson as Assistant Softball Coach for the 2021-2022 school year. Sarah Carter-Jones seconded the motion. All voted in favor.

Drew Power made a motion to approve the contract adjustment as presented for Kim Daugherty as Teacher for the 2022-2023 school year. Sarah Carter-Jones seconded the motion. All voted in favor.

Dan Furlin, Jr. made a motion to approve the contract adjustment as presented for Corrie Wray as Secretary for the 2022-2023 school year. Drew Power seconded the motion. All voted in favor.

Sarah Carter-Jones made a motion to approve the contract adjustment as presented for Bryson Dinwiddie as Athletic Director for the 2022-2023 school year. Drew Power seconded the motion. All voted in favor.

Drew Power made a motion to approve the hire of Ronald Valentine as JH Softball Coach for the 2021-2022 school year. Sarah Carter-Jones seconded the motion. All voted in favor.

Sarah Carter-Jones made a motion to approve the hire of Ronald Valentine as JH Football Coach for the 2022-2023 school year. Drew Power seconded the motion. All voted in favor.

Upcoming events noted were Day Care and PK Round UP on April 20, Prom at Bessie's Barn on April 22, School Carnival on May 5, and Graduation on May 14, 2022.

Items for next Board meeting to be held on May 16, 2022, include student fees for activity events.
