SEYMOUR COMMUNITY SCHOOL BOARD REGULAR MEETING

The regular meeting of the Board of Directors of Seymour Community School District was held on May 22, 2023, in the Board room of the Seymour Community School.

President Justin Keller called the meeting to order at 6:38 p.m.

Members present were Dan Furlin, Jr., Drew Power, Justin Keller, Sarah Carter-Jones, and Missy Liggett. Also present were Mr. Breon, Scott Valentine, Shannon Starr, Jamie Houser, Devon and Heather Sharp.

She also reported that graduation and the Senior trip are completed and recommended future Senior trips be held prior to graduation. May 25, 2023, will be a day of professional development training for staff beginning with Civilian Response and Casualty Care followed by Stop the Bleed Training. The last day of school and Eighth Grade graduation will be held on Wednesday, May 24, 2023.

Mrs. Starr reported Kindergarten graduation will be held on Tuesday, May 23, 2023, at 9:00 a.m. There are 11 student graduates.

There were no CSIAC meeting updates to report.
